Elbridge Russell and Gene Bergoffen nominated and seconded as directors for 3 year terms. 6 in favor none opposed, 2 abstained.

Don Thibodeau nominated and seconded as Chair : 7 in favor, none opposed, 1 abstained. Carl Thibodeau nominated and seconded as Vice Chair : 8 in favor, none opposed, no abstentions. 6.b. { taken out of order } Update & Developments : FAA funded projects

## Presented by Matt O'Brien :

Environmental assessment & alternatives - Runway needs less safety area than originally proposed. Part of the mowed area is now considered bird habitat. Some inland waterfowl habitat will be affected. The solution to minimize habitat impact is to extend both ends of the runway (14 & 32). Cost also reduced by \$100K +/-. May 1 deadline has been extended to July 1 for new environmental review. The bird habitat area identified behind the transient hangar can have topsoil stripped in winter so birds relocatein spring. MJ has had a preliminary meeting with Army Corps. If the wetlands are put in conservation, a 3rd. party conservator is required. The solar project could possibly pay an in-lieu fee in return for building the first section of the access road. Northern Borders is issuing a " notice of funding opportunities ". If tied to the solar project, NB match would be provided by the solar projet. BIL money is also available, but is a seperate application. An environmental public hearing / meeting required can be at planning boardor a site walk. We are seeking a Finding of No Significant Impact by May. Bidding for Taxiway & Runway to be simultaneous to reduce cost. 7 funding sources for project make it complicated. Data collection, final design & permitting phases are not funded up front but are reimbursable at a later date ( 09/2024 ). A short term loan from bank would tide us over till reimbursement.

The \$300K contract with MJ is needed by the end of Feb. 2024 to meet work timelines. Full invoice payment by end of June. FAA grant money in September. (3 month bridge loan needed). A letter of need is required by MEDOT to front their share.

Allison met with Katie Haley; review in progress. Audit is also progressing; the cost went up. Year net was \$40K +/-. No red flags. The Fryeburg budget request for this year is \$20K. Don noted that the Town of Fryeburg collects about \$13K in taxes from properties on the airport without any costs.

- a. Ron made a motion to affirm the actions taken by the Executive Committee since the last Board meeting; Don seconded; 8 in favor; none opposed; none abstained.

- d. Allison was asked if she spoke with Katie about the ESAA lease extension. It is not up this year; when negotiated it should be for 5 to 7 years. The Maine Municipal Association does not support eliminationg the Airplane excise tax. Some towns have said that if it goes away they will replace it with a personal property tax at a higher rate.
